Verification of eligibly form for New York State TASC™ applicants 16, 17, or 18 years of age who have reached maximum compulsory school attendance age (MCSAA) and have the additional qualifications to test. New York State required MCSAA age is reached when the school year in which the student turns 16 has ended (June 30). Some districts, including New York City, have a higher MCSAA - June 30<sup>th</sup> of the year a student turns 17 - as the board of education of the school district designates MCSAA as described in Section 3205(3) of Education Law. Age eligibility noted with an (\*) is subject to local MCSAA, where applicable.
